Information Sheet

Walgett Cultural and Community Aboriginal Corporation Aboriginal Community Controlled Mechanism is a community initiative, led by local Aboriginal people who are providing a volunteer service. It aims to support Aboriginal children and young people who are at risk of being removed from their families or carers in Walgett with the purpose to keep Aboriginal children and young people of this district on Country, with family and community, strong in culture.

What will this Aboriginal Community-Controlled Mechanism (ACCM) do?

Walgett Cultural and Community Aboriginal Corporation Aboriginal Community Controlled Mechanism provides volunteer members to support the needs of children, young people and families in the community. All members of this ACCM have a lived or professional experience in working with children, young people, families, and communities and hold a current Working With Children Check (WWCC) clearance.

The group have the skills and knowledge to inform and support local community to advocate for themselves/their rights, responsibilities and inform families of the resources available to them. Their goal is to support families to make well informed decisions when involved with the child protection system within this district.

Walgett Cultural and Community Aboriginal Corporation ACCM members advocate on behalf of children, young people and families for recognition of culture as a core/critical component of a child's identity. They are committed to upholding the rights of Aboriginal children, young people and families by working with NSW Department of Communities and Justice (DCJ) to make sure family finding, family group conferencing and family and community-led decision making is consistent and inclusive in local practice. The develop pathways for family restoration of Aboriginal children currently in out-of-home care (OOHC).

What service does this ACCM provide?

This ACCM is a community led program and its volunteer members are Aboriginal people who work in the local community, Aboriginal community members and Elders*.

1.Information to be shared

To assist this Aboriginal Community-Controlled Mechanism (ACCM) in providing the best support, care and advice to your family, it is helpful if they are able to access information relevant to your needs when working with you.

Walgett Cultural and Community Aboriginal Corporation ACCM will only receive your personal information in relation to the child protection matters that have been raised with DCJ. This information is provided in confidence to this ACCM and cannot be used by the ACCM for any other purpose than to support you in your interactions with DCJ.

2.How will your personal information be used?

Walgett Cultural and Community Aboriginal Corporation ACCM will use your information for the following purposes:

- Consider relevant support options and provide advocacy services for you.
- Demonstrate how positive change has been made by focusing on families' strengths.
- Speak to DCJ Community Services about cultural supports available within the community to suit your needs.
- To evaluate and assess the AbSec project Strong Families, Our Way so that this ACCM can continuously improve services to the community.

3.Data Sharing

When DCJ shares your information with Walgett Cultural and Community Aboriginal Corporation ACCM it will only be for the purpose you agree to. All record storage, security and confidentiality of your information will remain with and the responsibility of DCJ.

De-identified information may be collected by the ACCM. This information* will be used to evaluate whether the program/services provided to you met your family's needs or could be improved.

**de-identified information collected: date of service, gender, suburb, no. of children and outcome of service.*

4.Withdrawal of Consent

You can also tell us at any point if you no longer want your matter supported by Walgett Cultural and Community Aboriginal Corporation ACCM.

You can remove your consent at any time by contacting your caseworker from the Department of Communities and Justice.
